#### Public Hearings

A. <u>CASE NO. 1886-CUP</u>: Request by Sylvia Vega (for Jesus Gutierrez) for a Conditional Use Permit to establish a metal scrap yard at 2455 55<sup>th</sup> Street within the Industrial/Manufacturing Planned Development (MPD) Zone.

Assistant Planner Gabriela Silva presented the Administrative Report for Case No. 1886-CUP, which included the Municipal Code Requirements and Required Findings for a Conditional Use Permit, Administrative Comments and Analysis, and Recommendations. Ms. Silva stated that subject to the approval of the Conditional Use Permit, the proposed metal scrap yard would replace the existing truck repair and general equipment repair business. Ms. Silva added that, as conditioned, the proposed project complies with the development standards and that the Community Development staff recommended the approval of Case No. 1886-CUP, subject to Conditions Nos. 1-31 outlined in staff's report.

Chairman Benitez declared the public hearing open and called for those wishing to speak in favor of or against Case No. 1886-CUP. Ms. Sylvia Vega (1217 W. 243<sup>rd</sup> St., Harbor City, CA), representing the property owner, came forward and spoke in favor of the request.

A brief discussion ensued. Commissioner Molina inquired on the width of the site driveway entrance. Assistant Planner Silva stated that the driveway was wide enough for one commercial truck to enter or exit the site. Planning Manager Garcia added that the standard requirement for a two-way drive aisle is 24 feet (the existing driveway width measures 20 feet).

With no one else coming forward to speak for or against Case No. 1886-CUP, Chairman Benitez declared the public hearing closed.
A motion was made by Commissioner Lopez, seconded by Commissioner Molina, to APPROVE CASE NO. 1886-CUP, subject to Conditions Nos. 1-31, as outlined in the Administrative Report.
