Public Hearings

A. <u>CASE NO. 1910-DP/CUP</u>: Consideration of a request for a Development Permit and Conditional Use Permit by Sherrie Olson on behalf of 7-Eleven, Inc. to establish a convenience store with the off-sale of beer and wine within an existing commercial center located at 6224 Pacific Boulevard within the Downtown Specific Plan (DTSP) District A – Gateway Zone.

Assistant Planner Joanna Cortez reviewed the Administrative Report, which included the Municipal Code Requirements and Required Findings for a Development Permit and Conditional Use Permit, Administrative Comments and Analysis, and Recommendation. Ms. Cortez added that the applicant has proposed a security plan, which is subject to review and approval by the Planning Division and the Huntington Park Police Department. Ms. Cortez stated that based on the evidence presented, staff recommended the approval of Case No. 1910-DP/CUP, subject to Conditions No. 1-35 outlined in staff's Administrative Report.

Planning Manager Garcia reported that staff had received an unsigned letter of opposition to Case No. 1910-DP/CUP citing residents' concerns of exposure of alcohol sales to young children.

Chairperson Sanchez declared the public hearing open and called for those wishing to speak in favor of or against Case No. 1910-DP/CUP. Ms. Sherrie Olson (1030 N. Mountain Ave., Ontario, CA 91762), representing 7-Eleven, Inc., (7-Eleven) came forward to speak in favor of the request. Ms. Olson stated that 7-Eleven is promoting its "new image" of a friendly neighborhood market, deviating from the "alcohol outlet" which it has been known for in the past. Ms. Olson stated that 7-Eleven concurred with staff's recommended conditions, including the hours of alcohol sales, and requested that Case No. 1910-DP/CUP be approved.

Mr. Shawn Misra (7-Eleven, Inc., 330 E,. Lambert, #200, Brea, CA) came forward to speak in favor of Case No. 1910-DP/CUP. Mr. Misra stated that 7-Eleven has a management program for new franchisees, which includes regular store visits to ensure compliance with the organization's high customer service standards as well as its new image. Mr. Misra added that 7-Eleven's state-of-the-art security system is a major component of its proposed security plan.

With no one else coming forward to speak for or against the Case No. 1910-DP/CUP, Chairperson Sanchez declared the public hearing closed.

A motion was made by Commissioner Lopez, seconded by Commissioner Carvajal, to <u>APPROVE CASE NO. 1910-DP/CUP</u>, <u>subject to Conditions No. 1-35 as outlined in staff's report</u>. The motion carried as follows: Ayes: Commissioners Benitez, Perez, Carvajal, Lopez Noes: Chairperson Sanchez; Absent: None.
